- 5. Business Arising from the Minutes of the previous AGM

  The only matter not to be dealt with in later reports was that of the MERGA

  Constitution and By Laws being placed on the MERGA Website. This has not yet been achieved because of changes being undertaken with the location of the website.

# 6. Correspondence

6.1 MERGA received a request to make a submission to the Victorian government enquiry into the promotion of mathematics and science education. A submission was made on behalf of MERGA. Phil Clarkson and Peter Sullivan made a presentation to the enquiry.

#### 7. Reports

7.1 President's Report.

A group was formed under the leadership of Helen Forgasz and Margaret Walshaw. The 'promising researchers' group comprised Janeen Lamb, Brenda Menzal, Sedipeh and Fiona Hagan with the group of mentors Elizabeth Warren, Pat Forster and Tasmin Meaney. ## 7.2 Treasurer's Report (see attached)

Key points included that both membership subscriptions and publications were on par with those reported for the previous year; and the MERGA 2004 conference organisers had made more than \$10000 profit for MERGA (through their planning and willingness to take on a number of tasks that were scheduled to be done by paid helpers but were in fact done by the volunteers in the organising committee).

There was some discussion about whether MERGA should be seeking to run conferences that return large profits such as that returned by the 2004 organisers. It was stated that 2004 was an unusual year in this regard and that it was not expected that 2005 or 2006 would be a repeat of this situation. The Vice President (Conferences) took the points raised in the discussion on board for further consideration.

7.3 Vice President (Publications) Report (Published on MERGA website and in Conference Handbook)

Key points included the management arrangement that MERGA has entered into with AAMT, the need for a new editor of MERJ given that Helen Forgasz will retire from the position in mid-2006, the appointment of Sandra Frid, Len Sparrow and Merrilyn Goos as the editorial team for MTED, the appointment of Rosemary Callingham and Trevor Bond as guest editors for the 2006 special issue of MERJ, a request for papers to be written for both MTED and MERJ, and the process instituted by the MERGA executive for discussion of future publications policy, especially in the area of electronic publication.

Motion: That the Vice President (Publications) Report be noted [Moved Bill Atweh, Seconded Helen Forgasz; carried]

7.4 Vice President (Teaching) Report (Published on MERGA website and in Conference Handbook)

In the absence of the Vice President (Teaching), the report was presented by the Chair.

7.5 Vice President (Conferences) Report (Published on MERGA website and in Conference Handbook)

7.6 Vice President (Membership) Report (Published on MERGA website and in Conference Handbook)

The major point in this report concerned the possibility of some small difficulties as the management of MERGA membership issues moved to the AAMT and a pre-emptive apology for any such difficulties *Motion: That the Vice President (Membership) Report be noted* [Moved Jenni Way, Seconded Carmel Diezmann; carried]

7.7 Vice President (Research) Report (Published on MERGA website and in Conference Handbook)

Key points included congratulations to Jane Watson for her success in the PIA, thanks to the judges for both the PIA and ECA, and the Research Quality Framework and MERGA's response to it

Motion: That the Vice President (Research) Report be noted [Moved Carmel Diezmann, Seconded Beth Southwell; carried]

After her report had been noted the Vice President (Research) presented an acknowledgement to Phil Clarkson, the outgoing President, for his contribution over many years to MERGA. This acknowledgement was reiterated by the meeting through acclamation.

#### 8. Election of Officers

Two positions were open for election: President and Vice President (Teaching).

There was one nomination for President. The Chair declared Judy Mousley to be duly elected as MERGA President.

There were three nominations for Vice President (Teaching). After a ballot, the Chair declared Colleen McMurchy-Pilkington to be duly elected as MERGA Vice President (Teaching).

#### 9. Other business

- 9.1 Enquiries. There was some discussion around the role MERGA should play in current enquiries covering the area of mathematics education such as currently at the Australian government level and one in WA. It was felt that MERGA needed to be involved but how to do this sensibly needs to be thought through. Any input should be transmitted to Phil Clarkson for discussion by the executive.
- 9.2 The impact of Australian government Industrial Relations policy on mathematics education research. This matter is to be discussed by the executive.
- 9.3 PME Conference. There was a request for MERGA members who are attending the PME conference to attend the PME AGM and vote on the motions that are endeavouring to broaden PME's remit.

## 10. Close

The meeting was closed at 9.30 am by the Chair who thanked the MERGA community for its support during his Presidency.
